1. All details are to be filled up by the applicant in the 'Tender Form'.
2. The Tender envelope should be addressed to : The General Manager, O.F.Bhandara, PO Jawaharnagar, Dist: Bhandara (MS)– 441906.
3. A DD of R 25,000/- (Rupees Twenty Five Thousand only) of any nationalized bank drawn in favour of the General Manager, O.F.Bhandara payable at SBI Jawaharnagar branch to be enclosed with the Tender Form towards the Security deposit.
4. Standard package of digital channels should be made available to the customers. A list of channels that will be made available should be enclosed alongwith the Tender Form.
5. TRAI guidelines/ instructions must be strictly followed.
6. Lumpsum annual charge should be paid to the Factory in advance every year (Please mention annual charges 1,80,000/- as base price which is existing as on date).
7. The contract includes both the operation and maintenance part.
8. Channel packages will required to be upgraded as per demand.
9. A Call center/ Complaint center should be opened near to the Estate area so as to register the subscriber's complaints.
10. Tax and statutory payment to the Government should be borne by the contractor.
11. Subscription amount collection from the customers is to be done by the contractor and proper receipt should be issued for the same to the customers.
12. Subscription may be collected in cash, ECS or online payment method. Doorstep collection can be done at own cost.
13. There should be no subletting of the contract.
14. Fixed one time installation charge for set top box etc. can be charged from the customers.
15. Set top box can be either sold out to the subscriber or given on rental basis.
16. The cable operator should have valid Registration as per the instructions of Ministry of Information and Technology and submit a copy of the Registration documents alongwith the Tender form. Further whenever the registration is renewed, a copy of the same should be submitted to the Factory.
17. Cable network is to be set up by the contractor with own cost & material.
18. Customer complaints need to be attended within 48 hrs.
19. Subscription rates can be changed only with the permission of the Factory.
20. Free cable connection is to be provided to all rooms of GH-I & II, B & C mess, Ordnance club, WWA and Recreation club of the Factory.
21. Call center /complaint center / office timing should be 09:00 to 19:00 hrs.
22. General Manager / O.F.Bhandara reserves the right to accept or regret any Tender (even the highest bidder) without intimating reason thereof.
23. The tender will normally be given to the individual who quotes the highest rates.
24. The Security Deposit amount of all the applicants except the individual who is given the contract, will be returned.
25. The Security Deposit of the individual who is given the contract, will be returned only after successful completion of the contract term.
26. If the individual declared successful in the tender refuses to take over the contract, the security deposit money will be forfeited.
27. The contractor has to enter into a Lease agreement with the Factory. The expenditure for notarization etc. for preparation of the agreement will have to be borne by the contractor.

- 28. In case of non completion of the tenure of the contract or in case of any loss to the Factory property, the Security Deposit amount will be forfeited.
- 29. In case of any dispute, the decision of the General Manager/OFBa will be the final.
- 30. Any legal dispute arising during the term of the contract will fall under the jurisdiction of Bhandara court.
- 31. It will be the sole purview of the General Manager/OFBa to short close the contract at any point of time due to violation of any statutory rules or non-adherence to the instructions of the Factory management by the contractor or due to orders from the Government bodies. In that case, the Security deposit amount will not be returned.

I have read the above Terms and conditions (**SI.No. 01 to 31**) and they are acceptable to me. For any violation of the above terms of the contract, action as deemed fit can be taken against me by the General Manager, Ordnance Factory Bhandara.
